A BILL

- To amend the National Artificial Intelligence Initiative Act of 2020 to establish a center on artificial intelligence to ensure continued United States leadership in research, development, and evaluation of the robustness, resilience, and safety of artificial intelligence systems, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "AI Advancement and3 Reliability Act of 2024".

4 SEC. 2. ARTIFICIAL INTELLIGENCE ADVANCEMENT AND 5 RELIABILITY.

6 (a) IN GENERAL.—Section 5002 of the National Ar7 tificial Intelligence Initiative Act of 2020 (15 U.S.C. 9401;
8 as enacted as part of division E of the William M. (Mac)
9 Thornberry National Defense Authorization Act for Fiscal
10 Year 2021; Public Law 116–283) is amended—

(1) by redesignating paragraphs (4), (5), (6),
(7), (8), (9), (10), and (11) as paragraphs (6), (8),
(9), (10), (11), (12), (13), and (14), respectively;

14 (2) by inserting after paragraph (3) the fol-15 lowing new paragraphs:

16 (4)ARTIFICIAL INTELLIGENCE RED 17 TEAMING.—The term 'artificial intelligence red 18 teaming' means a structured testing in a controlled 19 environment simulating real-world conditions, using 20 adversarial methods to find flaws and vulnerabilities 21 in an artificial intelligence system and identify risks, 22 flaws, and vulnerabilities of artificial intelligence sys-23 tems, such as harmful outputs from such system, 24 unforeseen or undesirable system behaviors, limita-25 tions, and potential risks associated with the misuse 26 of such system.

| 17 | "(A) To evaluate the needs of stake- |
| 18 | holders, including industry and civil society. |
| 19 | "(B) To identify where gaps remain in the |
| 20 | activities of the Center, including relating to |
| 21 | measurement research and support for stand- |
| 22 | ards development, and provide recommenda- |
| 23 | tions to the Center on how to address such |
| 24 | gaps. |

1 "(3) REPORT.—Not later than two years after 2 the date of the enactment of this section, the Under 3 Secretary shall submit to the Committee on Science, 4 Space, and Technology of the House of Representatives and the Committee on Commerce, Science, and 5 6 Transportation of the Senate a report summarizing 7 the contributions of the members of the Consortium 8 in support the efforts of the Center.

9 "(c) SCIENTIFIC INTEGRITY.—The Under Secretary 10 shall ensure the Center, Consortium, and staff adhere to policies and procedures established pursuant to section 11 12 1009 of the America COMPETES Act (42 U.S.C. 6620), including by providing mechanisms for an employee or as-13 sociate of the National Institute of Standards and Tech-14 15 nology, a member of the Consortium, a private sector entity, researcher, or student affiliated with the Center or 16 17 Consortium, an employee of an agency working with the 18 Center, or a member of the public to report violations of 19 such policies by confidential and anonymous means.

"(d) SECURITY.—This section shall be carried out in
accordance with the provision of subtitle D of title VI of
the Research and Development, Competition, and Innovation Act (42 U.S.C. 19231 et seq.; enacted as part of division B of Public Law 117–167) and section 223 of the

William Mac Thornberry National Defense Authorization
 Act for Fiscal Year 2021 (42 U.S.C. 6605).

3 "(e) LIMITATION.—Information shared by an entity
4 with, or provided to, the National Institute of Standards
5 and Technology for the purpose of the activities described
6 in this section may not be used by any Federal, State,
7 local, or Tribal department or agency to regulate the activ8 ity of such entity.

9 "(f) PROHIBITIONS.—Nothing in this section may be10 construed to—

"(1) provide the Under Secretary any enforcement authority that was not in effect on the day before the date of the enactment of this Act;

14 "(2) confer any regulatory authority to any
15 Federal, State, Tribal, or local department or agen16 cy;

"(3) require any private sector entity to share
data, including proprietary information, with the
Under Secretary, the Center, or the Consortium; or
"(4) modify any regulatory requirement to report or submit information to a Federal, State, Tribal or local department or agency.

23 "(g) SUNSET.—This section shall terminate on the
24 date that is six years after the date of the enactment of
25 this section.

"(h) AUTHORIZATION OF APPROPRIATIONS.—There
 is to be authorized to be appropriated to the Under Sec retary \$10,000,000 for fiscal year 2025 to carry out this
 section.".

5 (c) HIRING CRITICAL TECHNICAL EXPERTS UP6 DATE.—Subsection (c) of section 6 of the National Insti7 tute of Standards and Technology Act (15 U.S.C. 275)
8 is amended by striking "section (b) shall expire on the
9 date that is 5 years" and inserting "subsection (b) shall
10 expire on the date that is 7 years".

(d) CLERICAL AMENDMENT.—The tables of contents
in section 2(b) and in title LIII of the William M. (Mac)
Thornberry National Defense Authorization Act for Fiscal
Year 2021 are amended by inserting after the items relating to section 5303 the following new items: "Sec. 5304. Center for AI Advancement and Reliability.".
