1	SEC NATIONAL SPACE GRANT COLLEGE AND FELLOW-
2	SHIP PROGRAM.
3	(a) Purposes.—Section 40301 of title 51, United
4	States Code, is amended—
5	(1) in paragraph (3)—
6	(A) in subparagraph (B), by striking
7	"and" at the end;
8	(B) in subparagraph (C), by adding "and"
9	after the semicolon at the end; and
10	(C) by adding at the end the following:
11	"(D) promote equally the State and re-
12	gional STEM interests of each space grant con-
13	sortium;"; and
14	(2) in paragraph (4), by striking "made up of
15	university and industry members, in order to ad-
16	vance" and inserting "comprised of members of uni-
17	versities in each State and other entities, such as 2-
8	year colleges, industries, science learning centers,
9	museums, and government entities, to advance".

· 1	(b) Definitions.—Section 40302 of title 51, United
2	States Code, is amended—
3	(1) by striking paragraph (3);
4	(2) by inserting after paragraph (2) the fol-
5	lowing:
6	"(3) LEAD INSTITUTION.—The term 'lead insti-
7	tution' means an entity in a State that—
8	"(A) was designated by the Administrator
9	under section 40306, as in effect on the day be-
10	fore the date of the enactment of the National
11	Aeronautics and Space Administration Author-
12	ization Act of 2020; or
13	"(B) is designated by the Administrator
14	under section 40303(d)(3).";
15	(3) in paragraph (4), by striking "space grant
16	college, space grant regional consortium, institution
17	of higher education," and inserting "lead institution,
18	space grant consortium,";
19	(4) by striking paragraphs (6), (7), and (8);
20	(5) by inserting after paragraph (5) the fol-
21	lowing:
22	"(6) Space grant consortium.—The term
23	'space grant consortium' means a statewide group,
24	led by a lead institution, that has established part-
25	nerships with other academic institutions, industries,

1	science learning centers, museums, and government		
2	entities to promote a strong educational base in t		
3	space and aeronautical sciences.";		
4	(6) by redesignating paragraph (9) as para-		
5	graph (7);		
6	(7) in paragraph (7)(B), as so redesignated, by		
7	inserting "and aeronautics" after "space";		
8	(8) by striking paragraph (10); and		
9	(9) by adding at the end the following:		
10	"(8) STEM.—The term 'STEM' means science,		
11	technology, engineering, and mathematics.".		
12	(c) Program Objective.—Section 40303 of title		
13	51, United States Code, is amended—		
14	(1) by striking subsections (d) and (e);		
15	(2) by redesignating subsection (c) as sub-		
16	section (e); and		
17	(3) by striking subsection (b) and inserting the		
18	following:		
19	"(b) Program Objective.—		
20	"(1) IN GENERAL.—The Administrator shall		
21	carry out the national space grant college and fel-		
22	lowship program with the objective of providing		
23	hands-on research, training, and education programs		
24	with measurable outcomes in each State, including		
25	programs to provide—		

. 1	"(A) internships, fellowships, and scholar-
2	ships;
3	"(B) interdisciplinary hands-on mission
4	programs and design projects;
5	"(C) student internships with industry or
6	university researchers or at centers of the Ad-
7	ministration;
8	"(D) faculty and curriculum development
9	initiatives;
10	"(E) university-based research initiatives
11	relating to the Administration and the STEM
12	workforce needs of each State; or
13	"(F) STEM engagement programs for kin-
14	dergarten through grade 12 teachers and stu-
15	dents.
16	"(2) Program priorities.—In carrying out
17	the objective described in paragraph (1), the Admin-
18	istrator shall ensure that each program carried out
19	by a space grant consortium under the national
20	space grant college and fellowship program balances
21.	the following priorities:
22	"(A) The space and aeronautics research
23	needs of the Administration, including the mis-
24	sion directorates.

1	"(B) The need to develop a national
2	STEM workforce.
3	"(C) The STEM workforce needs of the
4	State.
5	"(c) Program Administered Through Space
6	GRANT CONSORTIA.—The Administrator shall carry out
7	the national space grant college and fellowship program
8	through the space grant consortia.
9	"(d) Suspension; Termination; New Competi-
10	TION.—
11	"(1) Suspension.—The Administrator may,
12	for cause and after an opportunity for hearing, sus-
13	pend a lead institution that was designated by the
14	Administrator under section 40306, as in effect on
15	the day before the date of the enactment of the Na-
16	tional Aeronautics and Space Administration Au-
17	thorization Act of 2020.
18	"(2) TERMINATION.—If the issue resulting in a
19	suspension under paragraph (1) is not resolved with-
20	in a period determined by the Administrator, the
21	Administrator may terminate the designation of the
22	entity as a lead institution.
23	"(3) NEW COMPETITION.—If the Administrator
24	terminates the designation of an entity as a lead in-
25	stitution the Administrator may initiate a new com-

1	petition in the applicable State for the designation of
2	a lead institution.".
3	(d) Grants.—Section 40304 of title 51, United
4	States Code, is amended to read as follows:
5	"§ 40304. Grants
6	"(a) Eligible Space Grant Consortium De-
7	FINED.—In this section, the term 'eligible space grant
8	consortium' means a space grant consortium that the Ad-
9	ministrator has determined—
10	"(1) has the capability and objective to carry
11	out not fewer than 3 of the 6 programs under sec-
12	tion 40303(b)(1);
13.	"(2) will carry out programs that balance the
14	priorities described in section 40303(b)(2); and
15	"(3) is engaged in research, training, and edu-
16	cation relating to space and aeronautics.
17	"(b) Grants.—
18	"(1) IN GENERAL.—The Administrator shall
19	award grants to the lead institutions of eligible space
20	grant consortia to carry out the programs under sec-
21	tion 40303(b)(1).
22	"(2) Request for proposals.—
23	"(A) IN GENERAL.—Not later than 180
24	days after the date of the enactment of the Na-
25	tional Aeronautics and Space Administration

1	Authorization Act of 2020, the Administrator
2	shall issue a request for proposals from space
3	grant consortia for the award of grants under
4	this section.
5	"(B) APPLICATIONS.—A lead institution of
6	a space grant consortium that seeks a grant
7	under this section shall submit, on behalf of
8	such space grant consortium, an application to
9	the Administrator at such time, in such man-
10	ner, and accompanied by such information as
11	the Administrator may require.
12	"(3) Grant Awards.—The Administrator shall
13	award 1 or more 5-year grants, disbursed in annual
14	installments, to the lead institution of the eligible
15	space grant consortium of—
16	"(A) each State;
17	"(B) the District of Columbia; and
18	"(C) the Commonwealth of Puerto Rico.
19	"(4) USE OF FUNDS.—A grant awarded under
20	this section shall be used by an eligible space grant
21	consortium to carry out not fewer than 3 of the 6
22	programs under section 40303(b)(1).
23	"(c) Allocation of Funding.—
24	"(1) Program implementation.—

I		"(A) IN GENERAL.—To earry out the ob-
2		jective described in section 40303(b)(1), of the
3		funds made available under section 40306 each
4		fiscal year for the national space grant college
5		and fellowship program, the Administrator shall
6		allocate not less than 85 percent as follows:
7		"(i) The 52 eligible space grant con-
8		sortia shall each receive an equal share.
9		"(ii) The territories of Guam and the
10	Œ.	United States Virgin Islands shall each re-
11		ceive funds equal to approximately 1/5 of
12		the share for each eligible space grant con-
13		sortia.
14		"(B) MATCHING REQUIREMENT.—Each el-
15		igible space grant consortium shall match the
16		funds allocated under subparagraph (A)(i) on a
17		basis of not less than 1 non-Federal dollar for
18		every 1 Federal dollar, except that any program
19		funded under paragraph (3) or any program to
20		carry out 1 or more internships or fellowships
21		shall not be subject to that matching require-
22		ment.
23		"(2) Program administration.—
24		"(A) IN GENERAL.—Of the funds made
25		available under section 40306 each fiscal year

1	for the national space grant college and fellow-
2	ship program, the Administrator shall allocate
3	not more than 10 percent for the administra-
4	tion of the program.
5	"(B) Costs covered.—The funds allo-
6	cated under subparagraph (A) shall cover all
7	costs of the Administration associated with the
8	administration of the national space grant col-
9	lege and fellowship program, including—
10	"(i) direct costs of the program, in-
11	cluding costs relating to support services
12	and civil service salaries and benefits;
13	"(ii) indirect general and administra-
14	tive costs of centers and facilities of the
15	Administration; and
16	"(iii) indirect general and administra-
17	tive costs of the Administration head-
18	quarters.
19	"(3) Special programs.—Of the funds made
20	available under section 40306 each fiscal year for
21	the national space grant college and fellowship pro-
22	gram, the Administrator shall allocate not more than
23	5 percent to the lead institutions of space grant con-
24	sortia established as of the date of the enactment of
25	the National Aeronautics and Space Administration

1	Authorization Act of 2020 for grants to carry out
2	innovative approaches and programs to further
3	science and education relating to the missions of the
4	Administration and STEM disciplines.
5	"(d) TERMS AND CONDITIONS.—
6	"(1) LIMITATIONS.—Amounts made available
7	through a grant under this section may not be ap-
8	plied to—
9	"(A) the purchase of land;
10	"(B) the purchase, construction, preserva-
11	tion, or repair of a building; or
12	"(C) the purchase or construction of a
13	launch facility or launch vehicle.
14	"(2) Leases.—Notwithstanding paragraph (1),
15	land, buildings, launch facilities, and launch vehicles
16	may be leased under a grant on written approval by
17	the Administrator.
18	"(3) Records.—
19	"(A) IN GENERAL.—Any person that re-
20	ceives or uses the proceeds of a grant under
21	this section shall keep such records as the Ad-
22	ministrator shall by regulation prescribe as
23	being necessary and appropriate to facilitate ef-
24	fective audit and evaluation, including records
2.5	that fully disclose the amount and disposition

1		by a recipient of such proceeds, the total cost
2		of the program or project in connection with
3		which such proceeds were used, and the
4		amount, if any, of such cost that was provided
5		through other sources.
6		"(B) MAINTENANCE OF RECORDS.—
7		Records under subparagraph (A) shall be main-
8		tained for not less than 3 years after the date
9		of completion of such a program or project.
10		"(C) Access.—For the purpose of audit
11		and evaluation, the Administrator and the
12		Comptroller General of the United States shall
13		have access to any books, documents, papers,
14		and records of receipts relating to a grant
15		under this section, as determined by the Admin-
16		istrator or Comptroller General.".
17	(e)	PROGRAM STREAMLINING.—Title 51, United
18	States Co	ode, is amended—
19		(1) by striking sections 40305 through 40308,
20	403	10, and 40311; and
21		(2) by redesignating section 40309 as section
