A BILL

To amend the Energy Policy Act of 2005 to direct the Secretary of Energy to carry out a research, development, and demonstration program with respect to abandoned wells, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Abandoned Well Remedi-*
5 *ation Research and Development Act”.*

6 **SEC. 2. AMENDMENT TO THE ENERGY POLICY ACT OF 2005.**

7 *(a) IN GENERAL.—The Energy Policy Act of 2005 is*
8 *amended—*

9 *(1) by adding at the end of subtitle F of title IX*
10 *(42 U.S.C. 16291 et seq.) the following new section:*

11 **“SEC. 969E. ABANDONED WELLS RESEARCH, DEVELOP-**
12 **MENT, AND DEMONSTRATION PROGRAM.**

13 *“(a) ESTABLISHMENT.—Not later than 120 days after*
14 *the date of the enactment of this section, the Secretary of*
15 *Energy shall, in coordination with relevant Federal and*
16 *state agencies and entities, establish a research, develop-*
17 *ment, and demonstration program to improve—*

18 *“(1) data collection on the location of abandoned*
19 *wells;*

20 *“(2) the plugging, remediation, reclamation, and*
21 *repurposing of abandoned wells; and*

22 *“(3) strategies to mitigate potential environ-*
23 *mental impacts of documented and undocumented*
24 *abandoned wells.*

1 “(b) *ACTIVITIES.*—*The research, development, and*
2 *demonstration under subsection (a) shall include activities*
3 *to improve—*

4 “(1) *remote sensor capabilities, LiDAR capabili-*
5 *ties, optical gas imaging, magnetic survey technology,*
6 *and any other technologies relevant to the efficient*
7 *identification of abandoned wells;*

8 “(2) *understanding of how certain parameters of*
9 *abandoned wells affect methane emission rates of such*
10 *wells, including paramaters such as well age, well*
11 *depth, geology, construction, case material, and geo-*
12 *graphic region;*

13 “(3) *the efficiency and cost-efficacy of processes*
14 *for plugging, remediating, reclaiming, and*
15 *repurposing abandoned wells, including—*

16 “(A) *improvement of processes and tech-*
17 *nologies for the unique challenges associated with*
18 *plugging remote abandoned wells;*

19 “(B) *use of low carbon, lightweight cement*
20 *or use of alternative materials and additives for*
21 *plugging purposes; and*

22 “(C) *repurposing of abandoned wells for al-*
23 *ternative uses, including geothermal power pro-*
24 *duction or carbon capture, utilization, and stor-*
25 *age; and*

1 “(4) *understanding of the impacts of abandoned*
2 *wells on groundwater quality and contamination.*

3 “(c) *COORDINATION.—In carrying out the program es-*
4 *tablished under subsection (a), the Secretary shall ensure*
5 *coordination of these activities with State and local govern-*
6 *ments, institutions of higher education, the Department of*
7 *Energy National Laboratories, the private sector, and im-*
8 *pacted communities, including landowners within such*
9 *communities.*

10 “(d) *ABANDONED WELL DEFINED.—In this section,*
11 *the term ‘abandoned well’ means a well originally drilled*
12 *in connection with oil and gas operations that is not being*
13 *used, has not been plugged, and has no anticipated use in*
14 *oil and gas operations.*

15 “(e) *FUNDING.—There is authorized to be appro-*
16 *priated to the Secretary to carry out this section amounts*
17 *authorized pursuant to section 10771 of subtitle O of title*
18 *VI of the Research and Development, Competition, and In-*
19 *novation Act (enacted as division B of Public Law 117–*
20 *167), as follows:*

21 “(1) *For fiscal year 2024, \$30,000,000.*

22 “(2) *For fiscal year 2025, \$31,250,000.*

23 “(3) *For fiscal year 2026, \$32,500,000.*

24 “(4) *For fiscal year 2027, \$33,750,000.*

25 “(5) *For fiscal year 2028, \$35,000,000.*

1 “(f) *SUNSET.*—*This section shall terminate five years*
2 *after the date of the enactment of this section.*”; and

3 (2) *in the table of contents in section 1(b) (42*
4 *U.S.C. 15801 note), by inserting after the matter re-*
5 *lating to section 969D the following new item:*

“Sec. 969E. Abandoned wells research, development, and demonstration pro-
gram.”.

6 (b) *CONFORMING AMENDMENT.*—*Paragraph (6) of sec-*
7 *tion 10771 of subtitle O of title VI of the Research and De-*
8 *velopment, Competition, and Innovation Act (enacted as di-*
9 *vision B of Public Law 117–167) is amended—*

10 (1) *in the matter preceding subparagraph (A),*
11 *by striking “2026” and inserting “2028”;*

12 (2) *in subparagraph (A), by striking*
13 *“\$600,000,000” and inserting “\$507,500,000”;*

14 (3) *in subparagraph (B), by striking “and” after*
15 *the semicolon;*

16 (4) *in subparagraph (C)—*

17 (A) *by striking “\$1,000,000,000” and in-*
18 *serting “\$930,000,000”; and*

19 (B) *by striking the period and inserting “;*
20 *and”;* and

21 (5) *by adding at the end the following new sub-*
22 *paragraph:*

23 “(D) *\$162,500,000 to carry out abandoned*
24 *wells research, development, and demonstration*

1 *activities under section 969E of the Energy Pol-*
2 *icy Act of 2005, in accordance with such sec-*
3 *tion.”.*
