To establish in the National Institute of Standards and Technology the Foundation for Standards and Metrology, and for other purposes.
1 Be it enacted by the Senate and House of Representa
2 tives of the United States of America in Congress assembled
3 SECTION 1. SHORT TITLE.
This Act may be cited as the "Expanding Partner
5 ships for Innovation and Competitiveness Act".
6 SEC. 2. FOUNDATION FOR STANDARDS AND METROLOGY.

ESTABLISHMENT.—The

1	tion to be known as the "Foundation for Standards and
2	Metrology".
3	(b) Mission.—The mission of the Foundation shall
4	be to—
5	(1) support the Institute in carrying out its ac-
6	tivities and mission to advance measurement science,
7	technical standards, and technology in ways that en-
8	hance the economic security and prosperity of the
9	United States; and
10	(2) advance collaboration with researchers, in-
11	stitutions of higher education, industry, and non-
12	profit and philanthropic organizations to accelerate
13	the development of technical standards, measure-
14	ment science, and the commercialization of emerging
15	technologies in the United States.
16	(c) Activities.—In carrying out its mission under
17	subsection (b), the Foundation may carry out the fol-
18	lowing:
19	(1) Support international metrology and tech-
20	nical standards engagement activities.
21	(2) Support studies, projects, and research on
22	metrology and the development of benchmarks and
23	technical standards infrastructure across the Insti-
24	tute's mission areas.

1	(3) Advance collaboration between the Institute
2	and researchers, industry, nonprofit and philan-
3	thropic organizations, institutions of higher edu-
4	cation, federally funded research and development
5	centers, and State, Tribal, and local governments.
6	(4) Support the expansion and improvement of
7	research facilities and infrastructure at the Institute
8	to advance the development of emerging tech-
9	nologies.
10	(5) Support the commercialization of federally
11	funded research.
12	(6) Conduct education and outreach activities.
13	(7) Offer direct support to NIST associates, in-
14	cluding through the provision of fellowships, grants,
15	stipends, travel, health insurance, professional devel-
16	opment training, housing, technical and administra-
17	tive assistance, recognition awards for outstanding
18	performance, and occupational safety and awareness
19	training and support, and other appropriate expendi-
20	tures.
21	(8) Conduct such other activities as determined
22	necessary by the Foundation to carry out its mis-
23	sion.

1	(d) AUTHORITY OF THE FOUNDATION.—The Foun-
2	dation shall be the sole entity responsible for carrying out
3	the activities described in subsection (c).
4	(e) Stakeholder Engagement.—The Foundation
5	shall convene, and may consult with, representatives from
6	the Institute, institutions of higher education, the private
7	sector, non-profit organizations, and commercialization or-
8	ganizations to develop activities for the mission of the
9	Foundation under subsection (b) and to advance the ac-
10	tivities of the Foundation under subsection (c).
11	(f) Limitation.—The Foundation shall not be an
12	agency or instrumentality of the Federal Government.
13	(g) Support.—The Foundation may receive, admin-
14	ister, solicit, accept, and use funds, gifts, devises, or be-
15	quests, either absolutely or in trust of real or personal
16	property or any income therefrom or other interest therein
17	to support activities under subsection (c).
18	(h) TAX EXEMPT STATUS.—The Board shall take all
19	necessary and appropriate steps to ensure the Foundation
20	is an organization described in section 501(c) of the Inter-
21	nal Revenue Code of 1986 and exempt from taxation
22	under section 501(a) of such Code.
23	(i) Board of Directors.—
24	(1) Establishment.—The Foundation shall
25	be governed by a Board of Directors.

1	(2) Composition.—
2	(A) IN GENERAL.—The Board shall be
3	composed of the following:
4	(i) Eleven appointed voting members
5	described in subparagraph (B).
6	(ii) Ex officio nonvoting members de-
7	scribed in subparagraph (C).
8	(B) Appointed members.—
9	(i) Initial members.—The Sec-
10	retary, acting through the Director, shall—
11	(I) seek to enter into an agree-
12	ment with the National Academies of
13	Sciences, Engineering, and Medicine
14	to develop a list of individuals to serve
15	as members of the Board who are well
16	qualified and will meet the require-
17	ments of clauses (ii) and (iii); and
18	(II) appoint the initial members
19	of the Board from such list, if appli-
20	cable, in consultation with the Na-
21	tional Academies of Sciences, Engi-
22	neering, and Medicine.
23	(ii) Representation.—The ap-
24	pointed members of the Board shall reflect
25	a broad cross-section of stakeholders

1	across diverse sectors, regions and commu-
2	nities, including from academia, private
3	sector entities, technical standards bodies,
4	the investment community, the philan-
5	thropic community, and other nonprofit or-
6	ganizations.
7	(iii) Experience.—The Secretary,
8	acting through the Director, shall ensure
9	the appointed members of the Board have
10	the experience and are qualified to provide
11	advice and information to advance the
12	Foundation's mission, including in science
13	and technology research and development,
14	technical standards, education, technology
15	transfer, commercialization, or other as-
16	pects of the Foundation's mission.
17	(C) Nonvoting members.—
18	(i) Ex officio members.—The ex
19	officio members of the Board shall be the
20	following individuals or the designees of
21	such individuals:
22	(I) The Director.
23	(II) The Associate Director for
24	Laboratory Programs.

1	(III) The Associate Director for
2	Innovation and Industry Services.
3	(IV) The Associate Director for
4	Management Resources.
5	(ii) No voting power.—The ex offi-
6	cio members described in clause (i) shall
7	not have voting power on the Board.
8	(3) Chair and vice chair.—
9	(A) In General.—The Board shall des-
10	ignate, from among its members—
11	(i) an individual to serve as the chair
12	of the Board; and
13	(ii) an individual to serve as the vice
14	chair of the Board.
15	(B) Terms.—The term of service of the
16	Chair and Vice Chair of the Board shall end on
17	the earlier of—
18	(i) the date that is three years after
19	the date on which the Chair or Vice Chair
20	of the Board, as applicable, is designated
21	for the respective position; and
22	(ii) the last day of the term of service
23	of the member, as determined under para-
24	graph (4)(A), who is designated to be

1	Chair or Vice Chair of the Board, as appli-
2	cable.
3	(C) Representation.—The Chair and
4	Vice Chair of the Board—
5	(i) may not be representatives of the
6	same area of subject matter expertise, or
7	entity, as applicable; and
8	(ii) may not be representatives of any
9	area of subject matter expertise, or entity,
10	as applicable, represented by the imme-
11	diately preceding Chair and Vice Chair of
12	the Board.
13	(4) Terms and vacancies.—
14	(A) Term limits.—Subject to subpara-
15	graph (B), the term of office of each member
16	of the Board shall be not more than five years,
17	except that a member of the Board may con-
18	tinue to serve after the expiration of the term
19	of such member until the expiration of the 180-
20	day period beginning on the date on which the
21	term of such member expires, if no new member
22	is appointed to replace the departing board
23	member.
24	(B) Initial appointed members.—Of
25	the initial members of the Board appointed

1	under paragraph (4)(A), half of such members
2	shall serve for four years and half of such mem-
3	bers shall serve for five years, as determined by
4	the Chair of the Board.
5	(C) VACANCIES.—Any vacancy in the
6	membership of the appointed members of the
7	Board—
8	(i) shall be filled in accordance with
9	the bylaws of the Foundation by an indi-
10	vidual capable of representing the same
11	area or entity, as applicable, as rep-
12	resented by the vacating board member
13	under paragraph (2)(B)(ii);
14	(ii) shall not affect the power of the
15	remaining appointed members to carry out
16	the duties of the Board; and
17	(iii) shall be filled by an individual se-
18	lected by the Board.
19	(5) QUORUM.—A majority of the members of
20	the Board shall constitute a quorum for the pur-
21	poses of conducting the business of the Board.
22	(6) Duties.—The Board shall carry out the
23	following:
24	(A) Establish bylaws for the Foundation in
25	accordance with paragraph (7).

1	(B) Provide overall direction for the activi-
2	ties of the Foundation and establish priority ac-
3	tivities.
4	(C) Coordinate with the Institute the ac-
5	tivities of the Foundation to ensure consistency
6	with the programs and policies of the Institute.
7	(D) Evaluate the performance of the Exec-
8	utive Director of the Foundation.
9	(E) Actively solicit and accept funds, gifts,
10	grants, devises, or bequests of real or personal
11	property to the Foundation, including from pri-
12	vate entities.
13	(F) Carry out any other necessary activi-
14	ties of the Foundation.
15	(7) Bylaws.—The Board shall establish bylaws
16	for the Foundation. In establishing such bylaws, the
17	Board shall ensure the following:
18	(A) The bylaws of the Foundation include
19	the following:
20	(i) Policies for the selection of the
21	Board members, officers, employees,
22	agents, and contractors of the Foundation.
23	(ii) Policies, including ethical and dis-
24	closure standards, for the following:

1	(I) The acceptance, solicitation,
2	and disposition of donations and
3	grants to the Foundation, including
4	appropriate limits on the ability of do-
5	nors to designate, by stipulation or re-
6	striction, the use or recipient of do-
7	nated funds.
8	(II) The disposition of assets of
9	the Foundation.
10	(iii) Policies that subject all employ-
11	ees, fellows, trainees, and other agents of
12	the Foundation (including appointed voting
13	members and ex officio members of the
14	Board) to conflict of interest standards.
15	(iv) The specific duties of the Execu-
16	tive Director of the Foundation.
17	(B) The bylaws of the Foundation and ac-
18	tivities carried out under such bylaws do not—
19	(i) reflect unfavorably upon the ability
20	of the Foundation to carry out its respon-
21	sibilities or official duties in a fair and ob-
22	jective manner; or
23	(ii) compromise, or appear to com-
24	promise, the integrity of any governmental
25	agency or program, or any officer or em-

1	ployee employed by, or involved in a gov-
2	ernmental agency or program.
3	(8) Restriction on membership.—No em-
4	ployee of the Department of Commerce may be ap-
5	pointed as a member of the Board of Directors.
6	(9) Compensation.—
7	(A) IN GENERAL.—Members of the Board
8	may not receive compensation for serving on
9	the Board.
10	(B) Certain expenses.—In accordance
11	with the bylaws of the Foundation, members of
12	the Board may be reimbursed for travel ex-
13	penses, including per diem in lieu of subsist-
14	ence, and other necessary expenses incurred in
15	carrying out the duties of the Board.
16	(10) Liaison representatives.—The Sec-
17	retary, acting through the Director, shall designate
18	representatives from across the Institute to serve as
19	the liaisons to the Board and the Foundation.
20	(j) Administration.—
21	(1) Executive director.—
22	(A) In general.—The Foundation shall
23	have an Executive Director who shall be ap-
24	pointed by the Board, and who shall serve at
25	the pleasure of the Board, and for whom the

1	Board shall establish the rate of compensation.
2	Subject to the bylaws established under sub-
3	section (i)(7), the Executive Director shall be
4	responsible for the daily operations of the
5	Foundation in carrying out the activities of the
6	Foundation under subsection (c).
7	(B) Responsibilities.—In carrying out
8	the daily operations of the Foundation, the Ex-
9	ecutive Director of the Foundation shall carry
10	out the following:
11	(i) Hire, promote, compensate, and
12	discharge officers and employees of the
13	Foundation, and define the duties of such
14	officers and employees.
15	(ii) Accept and administer donations
16	to the Foundation, and administer the as-
17	sets of the Foundation.
18	(iii) Enter into such contracts and
19	execute legal instruments as are appro-
20	priate in carrying out the activities of the
21	Foundation.
22	(iv) Perform such other functions as
23	necessary to operate the Foundation.
24	(2) Administrative control.—No member
25	of the Board, officer or employee of the Foundation

1	or of any program established by the Foundation, or
2	participant in a program established by the Founda-
3	tion, may exercise administrative control over any
4	Federal employee.
5	(3) Transfer of funds to institute.—The
6	Foundation may transfer funds and property to the
7	Institute, which the Institute may accept and use
8	and which shall be subject to all applicable Federal
9	limitations relating to federally funded research.
10	(4) Strategic plan.—Not later than one year
l 1	after the establishment of the Foundation, the
12	Foundation shall submit to the Committee on
13	Science, Space, and Technology of the House of
14	Representatives and the Committee on Commerce,
15	Science, and Transportation of the Senate a stra-
16	tegic plan that contains the following:
17	(A) A plan for the Foundation to become
18	financially self-sustaining in the next five years.
19	(B) Short- and long-term objectives of the
20	Foundation, as identified by the Board.
21	(C) A description of the efforts the Foun-
22	dation will take to be transparent in the proc-
23	esses of the Foundation, including processes re-
24	lating to the following:

1	(i) Grant awards, including selection,
2	review, and notification.
3	(ii) Communication of past, current,
4	and future research priorities.
5	(iii) Solicitation of and response to
6	public input on the priorities identified by
7	the Foundation.
8	(D) A description of the financial goals
9	and benchmarks of the Foundation for the fol-
10	lowing ten years.
11	(E) A description of the efforts undertaken
12	by the Foundation to ensure maximum
13	complementarity and minimum redundancy
14	with investments made by the Institute.
15	(5) Report.—
16	(A) In General.—Not later than 18
17	months after the establishment of the Founda-
18	tion and not later than February 1 of each year
19	thereafter, the Foundation shall publish a re-
20	port describing the activities of the Foundation
21	during the immediately preceding fiscal year.
22	Each such report shall include with respect to
23	such fiscal year a comprehensive statement of
24	the operations, activities, financial condition.

1	progress, and accomplishments of the Founda-
2	tion.
3	(B) FINANCIAL CONDITION.—With respect
4	to the financial condition of the Foundation,
5	each report under subparagraph (A) shall in-
6	clude the source, and a description of, all sup-
7	port under subsection (g) provided to the Foun-
8	dation. Each such report shall identify the per-
9	sons or entities from which such support is re-
10	ceived, and include a specification of any re-
11	strictions on the purposes for which such sup-
12	port may be used.
13	(C) Publication.—The Foundation shall
14	make copies of each report submitted under
15	subparagraph (A) available—
16	(i) for public inspection, and shall
17	upon request provide a copy of the report
18	to any individual for a charge not to ex-
19	ceed the cost of providing such copy; and
20	(ii) to the Committee on Science,
21	Space, and Technology of the House of
22	Representatives and the Committee on
23	Commerce, Science, and Transportation of
24	the Senate.

1	(6) Audits and disclosure.—The Founda-
2	tion shall—
3	(A) provide for annual audits of the finan-
4	cial condition of the Foundation, including a
5	full list of the Foundation's donors and any re-
6	strictions on the purposes for which gifts to the
7	Foundation may be used; and
8	(B) make such audits, and all other
9	records, documents, and other papers of the
10	Foundation, available to the Secretary and the
11	Comptroller General of the United States for
12	examination or audit.
13	(7) Evaluation by comptroller gen-
14	ERAL.—Not later than five years after the date on
15	which the Foundation is established, the Comptroller
16	General of the United States shall submit to the
17	Committee on Science, Space, and Technology of the
18	House of Representatives and the Committee on
19	Commerce, Science, and Transportation of the Sen-
20	ate the following:
21	(A) An evaluation of the following:
22	(i) The extent to which the Founda-
23	tion is achieving the mission of the Foun-
24	dation.
25	(ii) The operation of the Foundation.

1	(B) Any recommendations on how the
2	Foundation may be improved.
3	(k) Integrity.—
4	(1) In general.—To ensure integrity in the
5	operations of the Foundation, the Board shall de-
6	velop and enforce procedures relating to standards
7	of conduct, financial disclosure statements, conflicts
8	of interest (including recusal and waiver rules), au-
9	dits, and any other matters determined appropriate
10	by the Board.
11	(2) Financial conflicts of interest.—To
12	mitigate conflicts of interest and risks from malign
13	foreign influence, any individual who is an officer,
14	employee, or member of the Board is prohibited
15	from any participation in deliberations by the Foun-
16	dation of a matter that would directly or predictably
17	affect any financial interest of any of the following:
18	(A) Such individual.
19	(B) A relative of such individual.
20	(C) A business organization or other entity
21	in which such individual has an interest, includ-
22	ing an organization or other entity with which
23	such individual is negotiating employment.
24	(l) Intellectual Property.—The Board shall
25	adopt written standards to govern the ownership and li-

- 1 censing of any intellectual property rights developed by the
- 2 Foundation or derived from the collaborative efforts of the
- 3 Foundation
- 4 (m) Full Faith and Credit.—The United States
- 5 shall not be liable for any debts, defaults, acts, or omis-
- 6 sions of the Foundation. The full faith and credit of the
- 7 United States shall not extend to any obligations of the
- 8 Foundation.
- 9 (n) Support Services.—The Secretary, acting
- 10 through the Director, may provide facilities, utilities, and
- 11 support services to the Foundation if it is determined by
- 12 the Director to be advantageous to the research programs
- 13 of the Institute.
- 14 (o) Nonapplicability.—Chapter 10 of title 5,
- 15 United States Code, shall not apply to the Foundation.
- 16 (p) AUTHORIZATION OF APPROPRIATIONS.—There
- 17 are authorized to be appropriated to the Secretary
- 18 \$1,500,000 for each of fiscal years 2025 through 2029
- 19 to carry out this section.
- 20 (q) Definitions.—In this section:
- 21 (1) Board.—The term "Board" means the
- Board of Directors of the Foundation, established
- pursuant to subsection (i).

1	(2) Director.—The term "Director" means
2	the Director of the National Institute of Standards
3	and Technology.
4	(3) FOUNDATION.—The term "Foundation"
5	means the Foundation for Standards and Metrology
6	established pursuant to subsection (a).
7	(4) Institute.—The term "Institute" means
8	the National Institute of Standards and Technology.
9	(5) Institution of Higher Education.—The
10	term "institution of higher education" has the
11	meaning given such term in section 101 of the High-
12	er Education Act of 1965 (20 U.S.C. 1001).
13	(6) NIST ASSOCIATE.—The term "NIST asso-
14	ciate" means any guest researcher, facility user, vol-
15	unteer, or other nonemployee of the National Insti-
16	tute of Standards and Technology who conducts re-
17	search or otherwise engages in an authorized activity
18	with National Institute of Standards and Technology
19	personnel or at a National Institute of Standards
20	and Technology facility.
21	(7) Relative.—The term "relative" has the
22	meaning given such term in section 13101 of title 5,
23	United States Code.
24	(8) Secretary.—The term "Secretary" means
25	the Secretary of Commerce.

1	(9) TECHNICAL STANDARD.—The term "tech-
2	nical standard" has the meaning given such term in
3	section 12(d)(5) of the National Technology Trans-
4	fer and Advancement Act of 1995 (15 U.S.C. 272
5	note).
