

Response:

The Petra Nova project has international financing with: (a) the Japan Bank for International Cooperation (JBIC) and (b) Mizuho Bank backed by Nippon Export and Investment Insurance (NEXI). Both JBIC and NEXI are Japanese government entities. We have received two NEXI Insurance Premium refunds. The first was received on February 1, 2019 and totaled \$22,969.81. The second was received on November 18, 2019 and totaled \$962,096.92. These payments are not directly from the government as the refunds are made to Mizuho Bank, who then transfers the amounts on to Petra Nova; however, listing these for completeness.
