

## **Federal Grants or Contracts:**

I serve at the request of the Secretary of Energy on the Nuclear Energy Advisory Committee. This is probono position and I'm not clear whether this is considered a "contract." Only travel is reimbursed.

I serve on many advisory bodies for different national laboratories. These labs are Contractor-Operated and I do not believe these would be considered "federal grants or contracts".

## Contracts or payments originating with a foreign government

I am sometimes asked to participate in international conferences where only my travel expenses are paid—I do not believe this would be considered as a contract or payment. Within the last two years, I have participated in such conferences, on a pro bono basis with only travel reimbursed, in France, Korea, and (this coming June) with the International Atomic Energy Agency in Austria.

I serve on the International Advisory Group for the Jordan Atomic Energy Commission. I receive an honorarium of \$15K for an annual weeklong meeting. Travel expenses are also paid.

I serve as a Distinguished Energy Fellow for the Institute of Energy Economics of Japan. I receive a \$1K honorarium for participating in an annual two day conference. Travel expenses are also paid. I was asked last year to write a brief article on the topic of my talk, for which I received a \$500 honorarium.

I serve on the International Safety Advisory Group for the Japan Atomic Energy Authority, for which I am paid a \$1K honorarium for each annual two day meeting. Travel expenses are also paid
