Over the last thirty-six months, Nanoracks was awarded \$21.5 million on various contracts with NASA related to the ISS. Most of this work was awarded through an IDIQ services Contract which has a maximum contract value of \$54 million. Activities under this contract include CubeSat deployment (mostly for NASA university programs), biomedical research, STEM activities and ISS maintenance. This also includes funding for a LEO Commercialization Study Contract.

Over the last 36 months, Nanoracks has been awarded \$11.6 million in contracts with international partner government space agencies to satellite deployment and support of the European Space Agency ISS external platform. This funding also includes several student research payloads conducted in the pressurized volume of the ISS and one media project.
