Dear Congressman Smith:

Please be advised that I represent SECNAP Network Security Corp. (“SECNAP”) with regard to your letter dated January 14, 2016 to Victor Nappe in which you have requested SECNAP to provide certain documents and information to your Committee (the “Request”) relating to Secretary of State Hillary Clinton’s private server. The information you requested is specified in paragraphs numbered 1 through 4 on page 3 of the Request. Likewise, the Request in numbered paragraph 1 and 3 pertain to documents and communications relating to Secretary Clinton’s “server or network,” while numbered paragraph 2 relates to documents and communications relating to Secretary Clinton’s “private server.” While SECNAP’s CloudJacket’s device was installed to protect a network operated by Clinton Executive Services Corp. (“CESC”), SECNAP does not know what servers were connected to CESC’s network at any point in time during which CloudJacket was installed, including any server utilized by Secretary Clinton.

Your Request also assumes that SECNAP had some role in safeguarding potentially sensitive or classified information on the network on which SECNAP’s CloudJacket’s device was installed; however, SECNAP undertook no such responsibility with regard to any of its customers including CESC.

In any case, CESC has not consented to SECNAP’s production of any information or documents responsive to your Request. Consequently, the only documents and information we can provide in response to your Request is that which does not require a consent of our customer. SECNAP therefore will not produce any documents responsive to numbered paragraphs 1

through 3 of your Request due to lack of customer consent. With regard to numbered paragraph 4, SECNAP has no documents responsive to this Request.
